Human Resources

- There were no COVID cases reported regarding employees or clubs last week. There are currently 33 positive cases reported in our zip code (85375).
- RCSCW COVID Task Force will meet as necessary to evaluate the latest information from the Arizona Dept. of Health and the CDC and prepared updated guidelines. We encourage the wearing of masks in areas of substantial or high transmission. You can also choose to wear a mask regardless of the level of transmission. At present time there is no mask mandate.

Sports Pavilion

- Summer Leagues are finished. Fall Leagues are full and begin on 9/1/21.
- Lizard Acres Pub revenue continues to be good.

B&F

- The GM and CFO are working with B&F Committee Chair on the CAP Trust Transfer of Association investment money.
- The annual Audit Report was completed and will be posted once the B&F committee has had the opportunity to review it. It appears no major findings were issued.
- Cost for Insurance for the coming year may see significant increases (Property/ Casualty, D & O, etc.).

Golf Operations

- For the first 15 days of August:
 - Rounds of Golf Rounds are up by 4% vs. August 2020.

 Revenue for green fees/cart fees are up by 6% vs. August 2020.
- The schedule for Group Play for the first three weeks of September will be out this week. Once Overseeding starts (September 24th) all Group Play will be suspended until all courses are through the overseeding process (Nov. 16th).
- We are interviewing a few applicants for the position of Pro-Shop assistant this week. Call Center and Player Assistant positions have been posted on line.

- Two-Person Best Ball is scheduled for Saturday, September 18th. We are accepting entries through Friday, Sept. 10th. There are currently 20 teams signed up.
- Twenty-five E-Z-GO golf carts were delivered on Thursday. We will start delivering carts to golf courses to replenish their fleet numbers or to add to them.

Golf Course Maintenance/Landscape Management

Course Maintenance:

- Shoreline Project Update (Trail Ridge) The Block Cells are scheduled to be filled with concrete this Wednesday. 200 tons of fill dirt per day is scheduled for this week weather permitting. Sod is scheduled for the 8th and 9th of September. Completion date for this project is set for mid-September. (2 Photos attached).
- The new Putting Green at Pebblebrook opened on Tuesday 8/10 to rave reviews!
- There was vandalism at Pebblebrook Golf Course on Saturday night. There was golf cart damage on 3 greens, #1, #12 and #14 and a broken flag stick and turf damage from sharp turns. (2 Photos attached).
- Rainfall totals from Friday night's storms cause several issues on our courses:
 - ♣ On average, golf courses received 1.25" of rain.
 - Cart Path Restrictions in effect all day Saturday.
 - Deer Valley closed all Saturday
 - ♣ Cart Path Restrictions lifted on Sunday.
 - Deer Valley back 9 had to stay closed on Sunday. Front 9 was open with no restrictions.
 - All courses back open Monday with no restrictions.

- Staff is working on outstanding Maintenance Repair Orders.
- Old wall material was removed from the Racquet Ball Courts and will be replaced with the new material. The old sections will be salvaged and reused elsewhere.
 Expect this project to be completed in a week.
