B&F

- We are working on the CAP Trust Transfer of investment money which we hope to have completed in September. We've sent letter to Vanguard to discontinue service.
- We will be starting discussion with The Hayes Group regarding going out to bid for Health Care coverage.
- There will be an audit review with Clifton Larson on Wednesday of this week. Audit results will be presented to the B&F Committee at their September Meeting.
- Cost for Insurance for the coming year may see significant increases (Property/ Casualty, D & O, etc.).
- Minimum Wage inflation is tied to the CPI (4 ½% to 5%).

Golf Operations

- For the first 8 days of August:
 - Rounds of Golf Rounds are up by 3% vs. August 2020.
 Revenue for green fees/cart fees are up by 6% vs. August 2020.
- Entries for the Saturday, September 18th two-Person Best-Ball event are being accepted. We will have somewhere between 64-90 players for this event. This kicks-off our Fall/Winter Series of events hosted by Golf Operations.
- Valley Vista High School Boys and Girls golf team practice will begin this week at Pebblebrook Golf Course. Five to eight players on each team are expected for each practice at Pebblebrook and Desert Trails Golf Courses.
- Liquor Licenses Updated Current Governing Board officers were submitted for approval from the AZ Department of Liquor License and Control. This is done on an annual basis to reflect the incoming officers for the Board.

Golf Course Maintenance/Landscape Management

Course Maintenance:

- Grandview Golf Course reopens Tuesday, 8/10/21
- Shoreline Project Update (Trail Ridge) Block for the wall was installed on Saturday. Signature Golf will waterproof the back side of the wall Tuesday. The block cells will be filled with concrete on Thursday. 1,500 tons of fill dirt is scheduled for delivery this week. Sod will be installed the week of August 23 and completion for this project is set for mid-September. (Photos attached).

Capital Improvements:

RH Johnson

 Metal Shop Addition - Facility is closed; APS provided design clearance for new electrical feeds and provided dates of 9/6 thru 9/10 to disconnect primary electrical from service panel before foundation can begin; Project progress on hold. Waiting for APS.

Metal Shop Project Update – Many members have been inquiring about the delay in construction to the Metal Shop's addition. In response, Karl, our Capital Projects Manager submits the following: Karl Wilhelm, in cooperation with Metal Shop Leadership Team closed the Metal Shop in June 2021 to begin relocation of equipment and demolition of existing structures which was completed successfully by late June. Projects Manager then began July 6, 2021 with the General Contractor's schedule, beginning preparation of the site for new building components. Prior to breaking ground, Blue Stake "Call 811 Before You Dig" and Private Utility Locating was completed with the results locating one of the multiple Primary Electrical Feeds outside of the 12' APS Electrical easement boundary. This primary feed is currently located inconveniently under the future foundations footing and requires disconnect by APS also resulting in APS providing new design criteria for the primary feed.

APS Project Representative provided the new design and specifications clearance on July 22^{nd} but have made it clear to Project Manager and General Contractor that the APS Planning Dept. is backlogged 6 weeks and cannot provide electrical disconnect until Sept. $6^{th} - 10^{th}$. Please understand we are doing all we can to overcome this delay and that the General Contractor is also eager and ready to begin construction.

Beardsley

 Beardsley Park Electrical Renovation: Awaiting delivery of Electrical Service Panel from manufacturer, expected week of 8/9/21; APS provided schedule to energize 8/19/21 for tentative project completion 8/20/21.

Deer Valley Pro Shop

 Trash/Storage Area Asphalt – (Safety & Structural) Convert Trash area approach from asphalt to concrete due to Trash vehicles weight crumbling asphalt; project dates 8/9 – 8/13/21.
