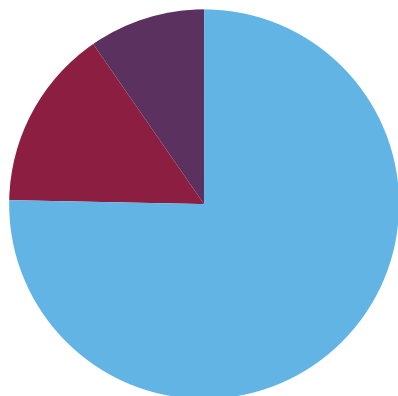

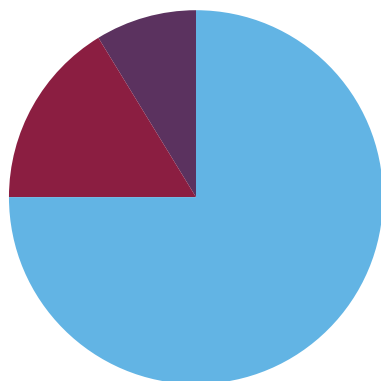

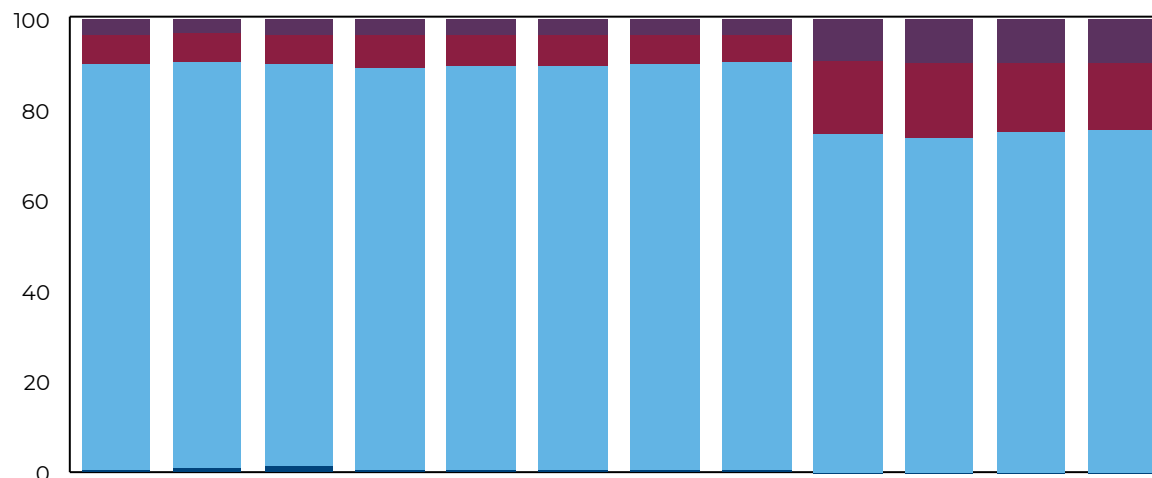
ACTUAL ALLOCATION
